

HOW THE FUNDRAISING PROGRAM WORKS

- Students may sell TaxSlayer Gator Bowl tickets at a discounted rate as a fundraiser for their school or organization.
- For each \$25 ticket sold (regularly \$50), \$15 is retained by the participating school.
- Funds raised are unrestricted.
- No collection of money or distribution of tickets required.
- Tickets sold by each participating school will be issued together in a block.
- Registration expires November 1, 2021.
- Ticket sales are cut off December 1, 2021.
- Sales are not restricted to members of the school community. Anyone is eligible to purchase – family friends, distant relatives, neighbors, etc.
- At the conclusion of the fundraiser, the TaxSlayer Gator Bowl will make one single payment of \$15 per ticket sold to the school!

SCHOOL MASCOT VISITS

- Our mascots, Mr. Tax and PATCHES, LOVE visiting local schools throughout the year as the official mascots of the TaxSlayer Gator Bowl!
- Mascot requests must be made at least 2 weeks in advance, so that the TaxSlayer Gator Bowl has adequate time to schedule your visit.
- Mascot visits typically last between 30 45 minutes unless otherwise agreed upon.
- Although our mascots cannot speak, they will be accompanied by a member of the TaxSlayer Gator Bowl staff who will be happy to discuss the school fundraising program and answer any questions.
- Please be sure to specify the type of event PATCHES will be attending. (IE. Fall festival, classroom visits, PTA meeting, assembly, etc.)
- Mascot appearances are limited to one visit per school per year.
- All mascot visits are subject to availability.

FREQUENTLY ASKED QUESTIONS

WHAT DO YOU MEAN BY THE FUNDS ARE UNRESTRICTED?

At the conclusion of the fundraising program, you will receive a check for the lump sum of \$15 per ticket sold. It's completely up to you how, when, where, why and what on the money will be spent with no questions asked by us. We do always love to hear your stories though of how the money is used if you're willing to share.

HOW LONG IS THE SCHOOL FUNDRAISING PROGRAM AVAILABLE?

Registration for the school fundraising program ends on November 1, 2021, and all sales must be completed by December 1, 2021. Each participating school club/organization will determine the timing & length of the program's sales within the allotted time frame (Now – December 1)

IS THERE A CERTAIN NUMBER OF TICKETS THAT MY GROUP MUST SELL?

No. You may sell any number of tickets. No matter the number sold, you keep \$15 per ticket to spend on your project. Only 2,500 tickets have been allocated to this program – when that number has been reached, the TaxSlayer Gator Bowl will cease ticket sales.

HOW DO I HANDLE HANDICAP ACCESSIBLE SEATING NEEDS?

There will be a handicap accessible ticket option they can purchase directly in the ticket platform. Please note: In order to accommodate all handicapped ticket requests, the TaxSlayer Gator Bowl asks that only one companion seat is requested per accessible ticket.

HOW ARE THE TICKETS DISTRIBUTED?

Our online platform, FEVO has made the process of distributing tickets seamless. Ticket buyers will make their purchase directly online and the tickets will be emailed to the purchaser directly. It's that simple. No distribution needed from the school!

HOW DOES FEVO WORK?

- Your school will receive a link and a promo code to provide prospective buyers.
- Send the link home with your students, post it on your social media page, etc. to
 encourage people to support your school by purchasing tickets to the TaxSlayer
 Gator Bowl.
- FEVO will collect all money and we will send one check to your school at the end of the fundraiser.
- FEVO will distribute all tickets via e-mail to purchasers between 24-48 hours in advance to kickoff.

CAN ONLY STUDENTS/PARENTS BUY TICKETS?

No! Tickets through your program can be purchased by anyone who wants to help your cause or sit in your school's block.
