HOW THE FUNDRAISING PROGRAM WORKS

- Youth organizations may sell TaxSlayer Gator Bowl tickets at a discounted rate as a fundraiser for their school or organization.
- **For each \$25 ticket sold (regularly \$50), \$15 is retained by the participating school or organization.**
- Funds raised are *unrestricted*.
- No collection of money or distribution of tickets required – it is all done online.
- Registration for the program expires October 31, 2025.
- Please allow 2 to 3 business days after registration is submitted for the link to be live.
- Ticket sales are cut off November 30, 2025 (prior to team selection)
- **Anyone is eligible to purchase – family, friends, distant relatives, neighbors, etc.**
- At the conclusion of the fundraiser, the TaxSlayer Gator Bowl will make one single payment of \$15 per ticket sold to the school/organization! Payment will be made out in the New Year (January/February).

*** Registration, W-9 & Waiver must be submitted to the TaxSlayer Gator Bowl by October 31, 2025. Ticket Sales link WILL NOT be made available until these items are all completed.**

SCHOOL MASCOT VISITS

- Our mascots, Mr. Tax and PATCHES, LOVE visiting local organizations/schools throughout the year as the official mascots of the TaxSlayer Gator Bowl!
- Mascot requests must be made at least 2 weeks *in advance*, so that the TaxSlayer Gator Bowl has adequate time to schedule your visit.
- Mascot visits typically last between 30 – 45 minutes unless otherwise agreed upon.
- Although our mascots cannot speak, they will be accompanied by a member of the TaxSlayer Gator Bowl staff who will be happy to discuss the youth fundraising program and answer any questions.
- Please be sure to specify the type of event PATCHES will be attending. (IE. Fall festival, classroom visits, PTA meeting, assembly, etc.)
- Mascot appearances are limited to one visit per organization/school per year.
- All mascot visits are subject to availability.

FREQUENTLY ASKED QUESTIONS

WHAT DO YOU MEAN BY THE FUNDS ARE UNRESTRICTED?

At the conclusion of the fundraising program, your organization/school will receive a check for the lump sum of \$15 per ticket sold. It's completely up to you how, when, where, why and what on the money will be spent with no questions asked by us. We do always love to hear your stories of how the money is used if you're willing to share.

HOW LONG IS THE ORGANIZATION/SCHOOL FUNDRAISING PROGRAM AVAILABLE?

Registration for the youth fundraising program ends on October 31, 2025, and all sales must be completed by November 30, 2025. Each participating organization/school will determine the timing & length of the program's sales within the allotted time frame (Now – November 30)

IS THERE A CERTAIN NUMBER OF TICKETS THAT MY GROUP MUST SELL?

No. You may sell any number of tickets. No matter the number sold, you keep \$15 per ticket to spend on your project. Only 1,000 tickets have been allocated to this program – when that number has been reached, the TaxSlayer Gator Bowl will cease ticket sales.

HOW DO I HANDLE HANDICAP ACCESSIBLE SEATING NEEDS?

Please contact the TaxSlayer Gator Bowl Ticket Office at 904-798-5999 for handicap accessible seating needs. The TaxSlayer Gator Bowl asks that **only one companion seat is requested per accessible ticket**.

HOW ARE THE TICKETS DISTRIBUTED?

Our online platform, FEVO has made the process of distributing tickets seamless. Ticket buyers will make their purchase directly online and the tickets will be emailed to the purchaser directly. It's that simple. No distribution needed from the school!

HOW DOES FEVO WORK?

- Your school will receive a link and a promo code to provide prospective buyers.
- Send the link with your students, share in an e-blast, post it on your social media pages, etc. to encourage people to support your school by purchasing tickets. (Graphics will be provided for you)
- FEVO will collect all money and we will send one check to your school at the end of the fundraiser (January/February)
- FEVO will distribute all tickets via e-mail immediately to the buyer after the purchase is confirmed.

CAN ONLY STUDENTS/PARENTS BUY TICKETS?

No! Tickets through your program can be purchased by anyone who wants to help your cause or sit in your organization/school's block.
